Aboriginal Culture and Healing Flood Recovery Grant Program

Six Aboriginal organisations from across Victoria will deliver flood recovery projects to assist their communities and heal Country, after being awarded grants through the Aboriginal Culture and Heritage (ACH) Flood Recovery Grant Program.

The Federation of Victorian Traditional Owner Corporations is pleased to deliver the million-dollar ACH Flood Recovery Grant Program in partnership with funding body Emergency Recovery Victoria (ERV).

"Caring for Country and healing community are central to how we live our culture as Aboriginal people. The terrible impact of climate change on our landscape, be it floods or fire or rising temperatures; impacts all plants, animals and people who live on Country. We are proud as a Federation of Aboriginal corporations to help by providing \$800,000 of assistance."

The grant program aims to assist Aboriginal communities affected by the October 2022 Victorian floods, which caused devastation across much of the State.

It recognises the unique impact that such flood events have on Aboriginal communities and seeks to strengthen the resilience of communities and Country to respond to future events.

Grant recipients have taken the lead and developed their own community-led solutions to address flood impacts and drive recovery.

"The Aboriginal Community and Moogji is grateful for assistance with easing the burden of flood recovery works to our Bonang Road site. The 2022 floods followed the trauma from the 19/20 Bushfires and Covid, tripling our need for resilience and challenges we have faced as a community in the Far East."
